



## Marine Notice No. 03 of 2022

*Notice to all Shipowners, Fishing Vessel Owners, Agents, Shipmasters, Skippers, Fishers,  
Yachtsmen and Seafarers*

### Deployment of Metocean Instrumentation at the North Ireland Sea Area (NISA)

#### 1. Notice of Activity

The Department of Transport has been advised that Partrac is planning to deploy Metocean Instrumentation at the North Ireland Sea Area (NISA). The deployment is expected to be completed over a two-day period from 17<sup>th</sup> January 2022.

#### 2. Location of Activity

The exact location co-ordinates of the buoys are as follows:

The survey campaign will be undertaken within the proposed NISA OWF array area. This area forms an irregular, approximately rectangular shape, spanning 31 km north-south and 14km east-west at its widest point. At its closest location, near Rush in Co. Dublin, the array area is approximately 7.4km from the coastline. A map detailing the location is provided below see Appendix 1.

On completion of the deployment operations, Site A instruments will remain deployed for 12 months. Site B instruments will be deployed for 6 months.

### 3. Details of Vessel

A Damen Shoalbuster 2409, versatile multi-purpose and shallow draft tug named **AMS Retriever** (Call Sign **MEH18**) will carry out the work. During operations the vessel will be restricted in its ability to manoeuvre. Vessels are requested to leave a wide berth during the deployment operations. Radio transmissions will be conducted with other seafarers to notify them of the operations.

### 4. Buoy Characteristics

#### Guard Buoy

Partrac will deploy two Poseidon 1750 Ocean Buoys. The buoy has a hull diameter of 1.75m and height above water level of 2.6m. Both buoys will be yellow in colour and displaying St. Andrew's Cross day shapes. They will be fitted with a radar reflector and a navigation light with a 3 Nm range, flashing sequence: Y. Fl. (5) 20s. The guard buoy deployed at Site A will also be fitted with AIS.

#### Wave Buoy

Yellow Spherical buoy with a diameter of approx. 1.1m. Buoy Light IALA yellow. Group flashing character of 5 flashes every 20 seconds - Fl(5) Y 20s Range of 3 nm.
